There are no exceptions for rape or incest. While there are narrow exceptions for "life-threatening," the lack of a clear definition has caused dangerous delays, denials of care, & even preventable death.

Doctors who violate the ban can lose their license, face felony charges, up to 99 years in prison & a \$100,000 fine.

SBB allows any citizen to sue anyone they suspect of helping someone access an abortion.

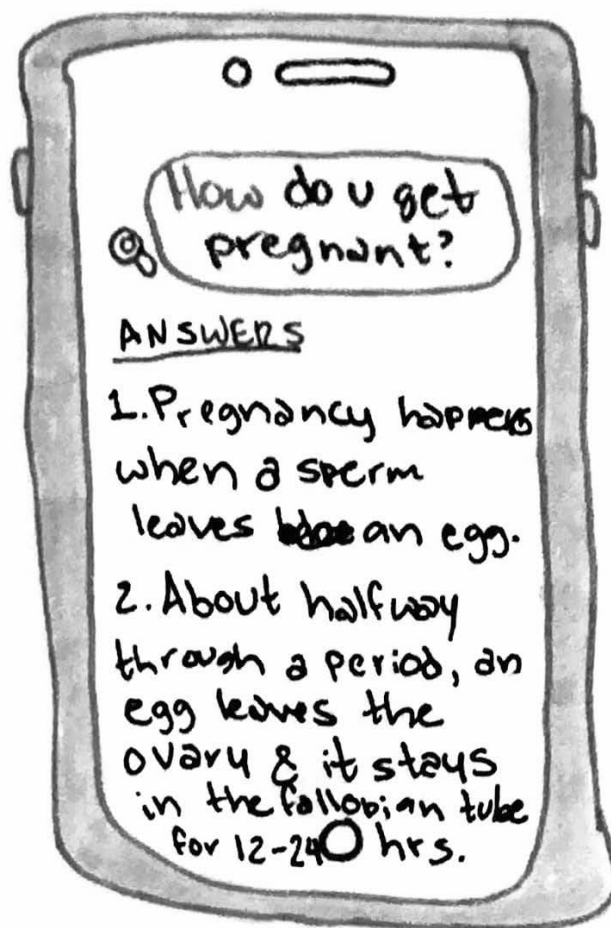
Consent

An agreement between participants to engage in sexual activity. Consent should be clearly & freely communicated.

A verbal & affirmative expression of consent can help you & your partner(s).

Consent cannot be given by individuals who are underage, intoxicated, or incapacitated by drugs, alcohol or asleep or unconscious.

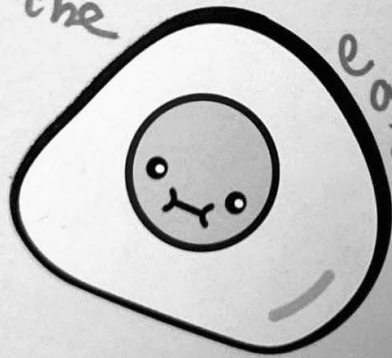

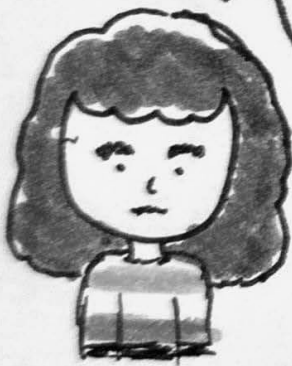

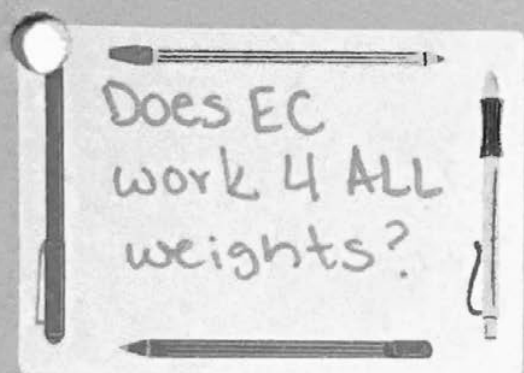
How does oral emergency contraception (EC) work?

EC works to PREVENT pregnancy by preventing or delaying ovulation.

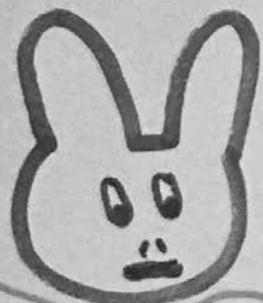
If an egg



has already been released, taking oral EC will NOT prevent pregnancy.

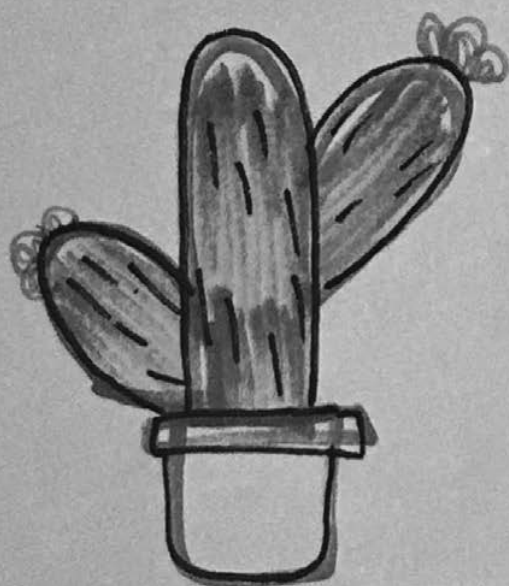

How does

copper IUD prevents
fertilization by causing
a chemical change in
sperm & egg b4
they meet.

• An IUD can also work as EC
regardless of weight if inserted
within **120** hours or 5
days after

having unprotected
sex. But an IUD
has to be inserted
by a medical
provider.

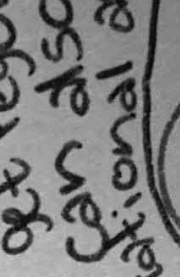
Common pregnancy symptoms:



- Missed period
- Swollen / tender breasts
- Nausea and/or vomiting
- Feeling tired & bloated
- Constipation
- Peeing more than usual



Start counting from the 1st day of your last period. It can be confusing bc ~~you~~ doctors measure pregnancy from your last period, about 3-4 weeks before you're actually pregnant.

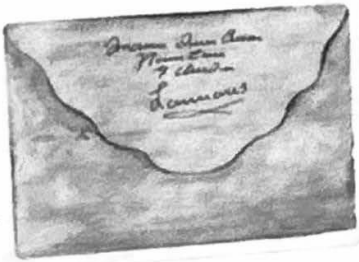

What should I consider before taking abortion medication?

- If you have an IUD, it should be removed by taking the abortion med.
- An allergy to mifepristone
- History of ectopic pregnancy (such as anemia)
- Taking blood thinning medication (except Aspirin)

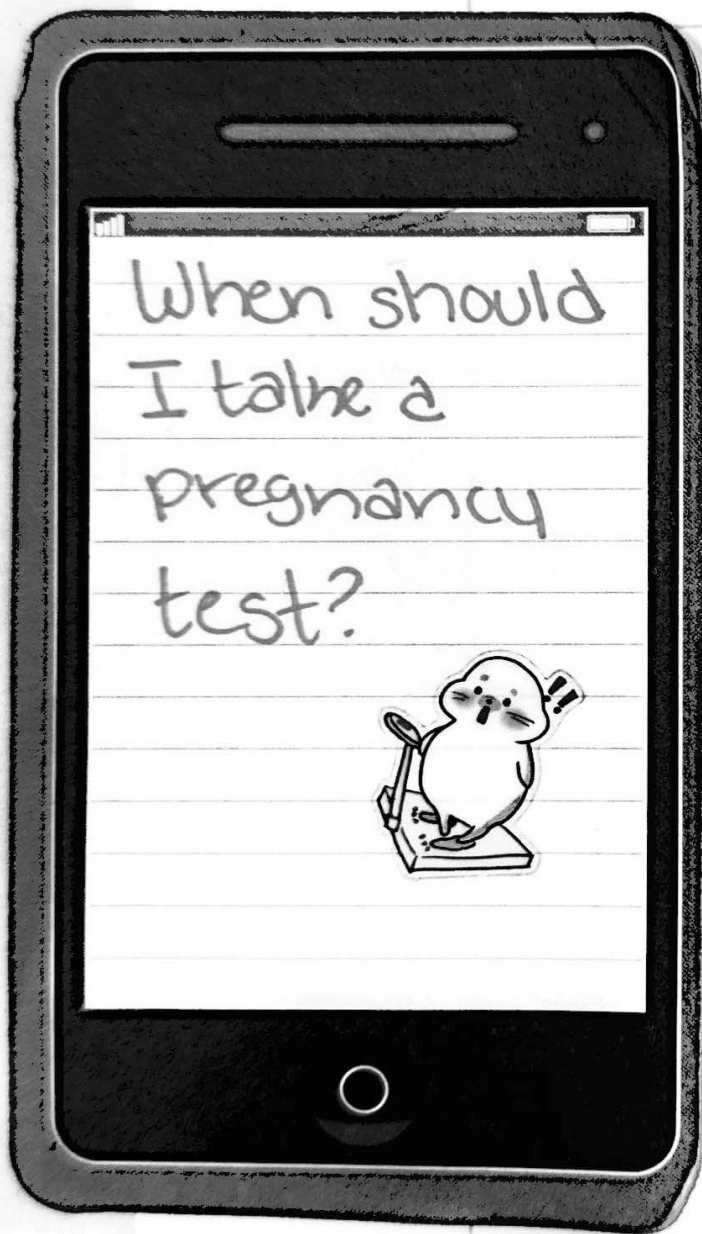
If any of these apply, it's important to take extra precautions & someone could even reach out to the M+A hotline for more info.





How do I know if I
should seek medical
attention? ?????

- If you have very heavy bleeding & soak thru more than 2 overnight maxi pads per hour, for more than 2 hours straight.
- Have a fever of 100.4°F or higher for more than 24 hours.
- Fever above 102.2°F for any duration.



Pregnancy hormones in the body can result in a false positive if taken too soon. Wait 4-6 weeks after an abortion b4



taking a pregnancy test to make sure it's negative.

● Encountering ICE in Public

1. Ask if u are free to leave. If so, calmly walk away. We know it can be scary.
2. You have the right to refuse consent to a search.
3. You have the right to remain silent. You do not need to discuss ur immigration status w anyone, such as where u were born or entered the country.



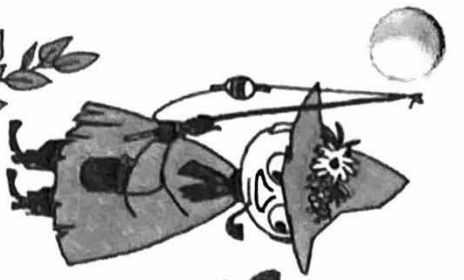
4. If u have valid immigration documents, u should show them. Never show fake ones.

5. If u are arrested, say that u wish to remain silent until speaking w a lawyer.



6. You have the right to record your interaction w immigration agents as long as you do not interfere.





Know Your Rights: ERs

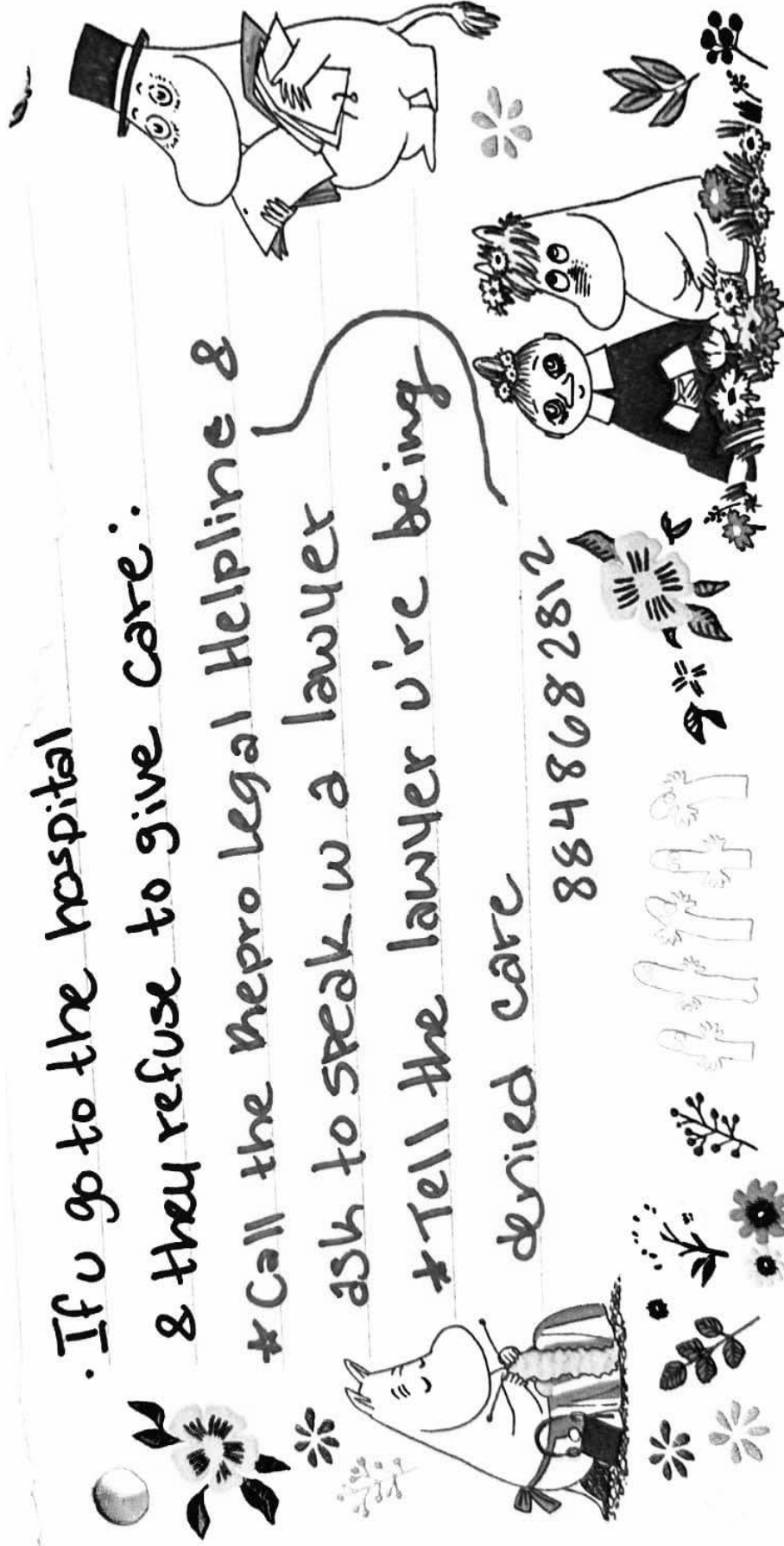
• What to say when u get to the hospital after an abortion/miscarriage:

- * There's NO law that says u have to tell anyone about having an ab.
- * Staff will NOT know whether u had a medication abortion



• If u go to the hospital
& they refuse to give care:
* Call the Repro Legal Helpline &
ask to speak w a lawyer
* Tell the lawyer u're being
denied care

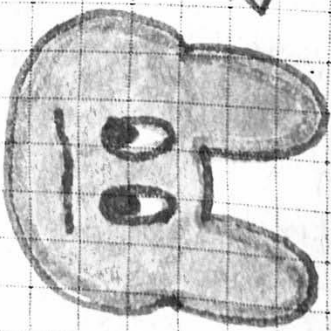

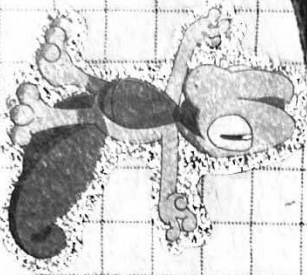

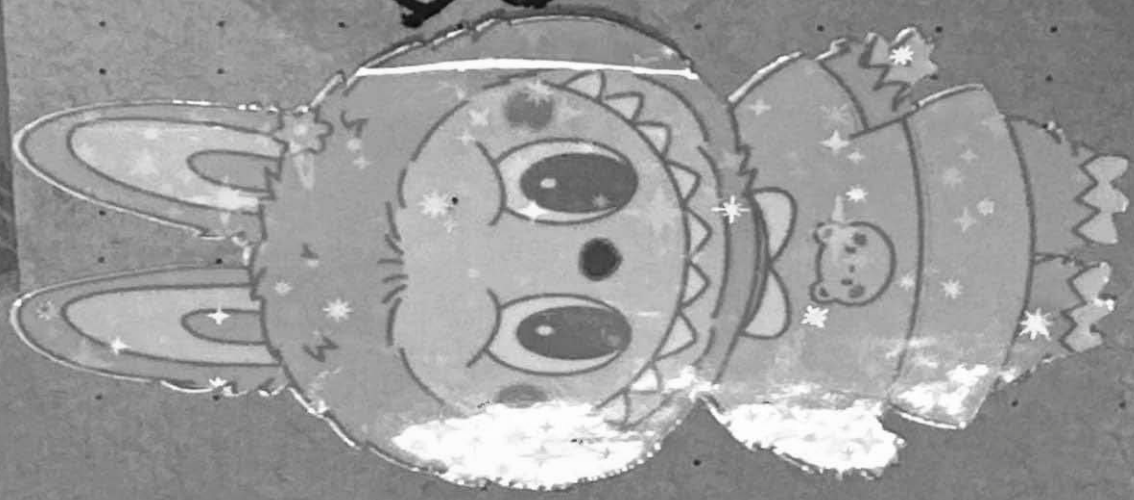




How to ID CPCs!

1. They do not clearly state what services they offer. Their objective is to get u in the door w free services to offer u mis-leading info about ab. If they use words like "choice" but can't clearly state over the phone whether they offer ab or not, they're likely a fake clinic.

2. They might have misleading names like "Women's Health Center" or "Pregnancy Resource Center."
